# Minnesota Citizens Personal Protection Act Fact Sheet

### Carry permits:

- · Issued by Sheriff's departments
- · Good for five years
- · Applicants must pass a rigorous criminal, drug and mental health background check.
- Applicants must pass a carry permit course taught by an instructor who is certified by a state-approved training organization.

## Carrying with a permit:

#### Mode of carry

- · Permit holders may carry as many guns as they wish.
- Permit holder may carry pistols or revolvers, shotguns or rifles (MN Stat 624.7181).
- · Guns may be carried either concealed or exposed.

#### **Prohibited Places**

- Federal Buildings (18 USC 930) There appears to be an exception that would apply to permit holders, but it is untested. Carry is not recommended.
- · Courthouses (unless county sheriff is notified) (MN 609.66)
- State Capitol (unless DPS is notified) (MN 609.66)
- Jails, correctional facilities and state hospitals (not county hospitals, or private hospitals, unless posted) (MN 243.55)
- · Secure areas of airports (past the scanners)
- Schools and licensed day care facilities, except parking lots (unless given permission by head school official) (MN 609 66)
- · Properly posted (or verbally notified) private property
- 187 square inch sign
- · Posted at every entrance
- 11/2 inch black Arial letters
- · A bright, contrasting background
- Must say exactly, "[Name of Business] bans guns in these premises"
- · Bottom of sign 4-6 feet above floor
- · Sign within 4 feet laterally of entrance

A November 2006 district court ruling allows churches to ban carry in any legal manner, and to forbid carry in their parking lots.

#### Carrying without a permit:

A permit is not required to carry a loaded gun:

- · In a person's home or on his land
- In their place of business
- · When traveling between home and business
- When traveling to or from a gun repair facility to have the gun repaired

#### Drinking and Carrying (MN 624.7142)

- Permit holders may carry in a bar or restaurant, unless it is posted.
- A BAC over .04 is a misdemeanor
- A repeat offense above .10 is a gross misdemeanor.
- The gun is NOT subject to forfeiture.

#### Non-prohibited places

- Other state, county or local government buildings and facilities can NOT be legally posted.
- Non-secure areas of public airports can NOT be legally posted.
- City, county or state parks can NOT be legally posted.
- Bars and restaurants (unless posted)
- Churches and other religious-use property (unless notice is given) A November 2006 district court ruling allows churches to ban carry in any legal manner, and to forbid carry in their parking lots.
- Parking lots (even of schools and posted buildings) can NOT be posted.

#### Penalty -- carrying on posted private property

- Property holder must demand compliance and ask permit holder to leave
- · Permit holder must refuse to leave
- \$25 petty misdemeanor
- The gun may NOT be confiscated.

#### Transporting a gun:

To legally transport a handgun in an automobile, boat or snowmobile *without a permit*, it must be:

- Unloaded, and
- Contained in a closed and fastened case, gunbox, or securely tied package. Warning: A Minnesota court ruling specifically excludes purses!

Note that the unloaded, encased handgun does **not** need to be placed in the trunk of the vehicle; it may be placed anywhere in the vehicle, provided that it is unloaded and encased.
